UCJCI Child Care and Protection Policy

At the **2015 Synod** of the United Church in Jamaica and the Cayman Islands a Resolution was passed to develop a **Child Care and Protection Policy** for the whole church. The policy not only protects our children but also protects our leaders, most of whom are volunteers. For the United Church this is more than just writing a statement or providing guidelines, this is a **powerful commitment** – a totally **new strategy of engagement** – **a church that values its children and young people above rubies. Every child matters!** The word **"children"** in the Policy includes infants, children of tender years and young persons up to the age of 18 affiliated to the United Church in Jamaica and the Cayman Islands. The Policy provides a core set of ground rules for our ministry to and with children in our church. The terms and conditions of the policy raise awareness about the responsibilities, risks and boundaries of working with children to facilitate a safer

Observance and adherence to this policy is expected of **Clergy**, **Elders**, **Sunday School Teachers** and **Superintendents**, **Youth Leaders**, **Camp Counselors**, **Volunteers** and all adults within the Church environment, with whom the children interface on a regular basis. On Saturday, 17th November, 2018, **seventeen persons (17)** participated in the Child Care and Protection Policy Workshop held at the Webster Memorial Church Hall, Bodden Town. Participants were from three Congregations, namely John Gray Memorial, Webster Memorial and **William Pouchie Memorial**. This workshop was specifically organized so that the volunteers in these Congregations who had not yet had the training could become qualified to work with our children and youth.

These seventeen (17) persons join the **one hundred and twenty six** (126) persons who have already been trained in the Child Care and Protection Policy in this Region. Training began in 2016 and will continue until all those who work with children and youth in our Congregations in Cayman have been exposed to the depth of the policy.

FOR WHOM WILL YOU BE AN ADVOCATE?

In this final quarter of 2018, the United Church in Jamaica and the Cayman has been placing an emphasis on **the public witness of the Church** and on our role as **advocates in the society**. An advocate is a **helper** or **comforter** who is called to the aid of the **'other'**. An advocate will make costly sacrifices for others without counting the cost. Advocates do not have ulterior motives and the Christian advocate does all to the glory of God, Soli Deo Gloria.

As Christians we have '**paracletos**'-the Holy Spirit as our Advocate. The Holy Spirit is called on constantly to come to our aid as counsellor and guide. The Holy Spirit is our defender; intercessor and helper when we are face the wiles of the Accuser. The Advocate counters the work of the Accuser with good deeds, dunamis (moral power and excellence of soul) and love.

In the Church we must act in ways that counter works that are not meant for good. The arc of the work of the Church must bend towards good deeds. And as such, the **core of our advocacy** must be based on our genuine **love for people**, love for their souls and a determination towards sincerity and honesty as we interact with the most vulnerable.

We need to stand and speak for those who are defenselesschildren, the poor, the marginalized, the unemployed, the sick, the less-abled, refugees, and those mentally challenged and even strangers. We are all made in the **image of God** and as such we, who serve Christ, must never devalue anyone but must instead ensure their well-being and seek always for surround them with goodness.

We must hear the cry of the wounded and stand with them in the painful spaces.

Congregations are encouraged to identify individuals and issues that need the voice, strength and commitment of the Church and stand in the gap with them. **For whom will you be an advocate**?

Achieving and maintaining best practice in the safety and care of children is inextricably tied to this call to "mutual respect, care, protection and empowerment" and is taken to be the responsibility of the membership at large in each Congregation.
