## Understanding Vaccines

While taking the Covid-19 Vaccine is a matter of choice, we encourage each person to give due consideration to the matter to prevent adverse effects.

We were joined on several occasions by Dr Delroy Fray, a member of the United Church and the Clinical Coordinator at the Western Regional Health Authority (WRHA), to discuss the COVID-19 vaccines. In one instance, he shared that 99.9 per cent of COVID admitted patients in WRHA did not take the vaccine. According to the Ministry of Health in Jamaica, the 1,860 persons who have died from COVID-19, so far, were unvaccinated.

At a point, only three COVID patients at the Cornwall Regional Hospital received the first dose of the vaccine, Dr Fray said. He reported that those three people were only admitted for a few days before being discharged. Westmoreland recently experienced a spike in COVID cases, especially among children.

*Here are some questions and concerns addressed in the various fora:*

### The length of time within which the vaccine was developed

The Coronavirus is the simple flu virus. This means that it has been studied for years which give scientist information about the mutated virus, COVID-19, and it's behaviors.

### How does the vaccine work?

The vaccine stimulates your immune system to make antibodies and store those in memory cells so that in the event that you are exposed to the virus then the body will be able to produce vast of amounts of antibodies to fight off the virus .

### Can vaccinated persons contract the virus?

Vaccinated persons do contract the virus however they are better able to fight the virus so they do not get severely ill. Some persons can get fully vaccinated and still get severely ill but those persons are immunocompromised patients.

### Can you develop immunity from contracting the virus?

Getting the virus causes your body to develop natural antibodies to fight the virus but all persons cannot be allowed to contract the virus in order to develop natural immunity. Many would die therefore the vaccine is acts as a buffer to prevent deaths.

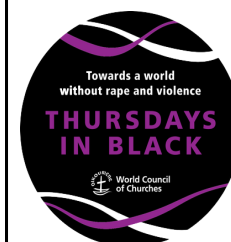

Based on how it works we are going to have surges of coronavirus from time to time for a very long time and vaccination will allow some amount of protection.

Do you still need to get vaccinated after contracting the virus?

Yes, there is no data to show how long natural immunity will last. Getting vaccinated is double or guaranteed protection.

How long after recovering from the virus should one take the vaccine?

Wait at least a month or two after contracting the virus to take the vaccine.

Does it affect fertility in women and sexual competence in men?

No, it doesn't affect fertility in women and it does not affect sex cells.

What are some of the symptoms that one may still experience after recovery?

Long COVID is when symptoms continue up to 12 weeks after. These symptoms include muscle weakness and joint pain, dry cough, mild or severe infection, short of breath while walking.

Will all vaccines need booster shots?

Recent studies are showing that the AstraZeneca vaccine may have a long term effect and may not require a booster shot. Research is showing that other vaccines such as the Pfizer will require booster shots.

## Senior Citizen Home in Manchester seeks assistance

Along with the main house, the property has two (2) separate dorms, a two-bedroom flat and a two-bedroom cottage that give the options of comfortable rooms for single, double and triple occupancy. There is also a very large kitchen and a spacious dining room. Located on Villa Road, perched on the outskirts of the town of Mandeville, residents have easy access to medical, shopping, banking, car rental and worship facilities.

Adding to the perks, they offer round the clock nursing care, medical personnel on call, and the fellowship of caring church folks from various denominations.

### SENIORS' FELLOWSHIP AT JOHN GRAY MEMORIAL UC

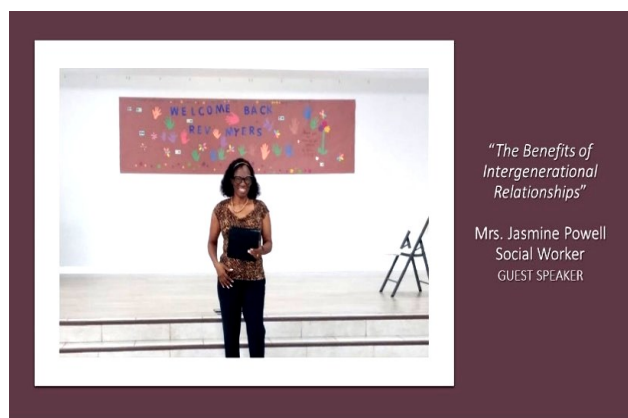

## CONSTITUTION CORNER



This month's edition of Constitution Corner will take a look at Congregational Meetings. The following information is contained in Section 2(a) of the Constitution.

### How Often Should a Congregational Meeting be held?

Congregational Meetings shall be held at least three times per year.

### Who Shall Preside over the Congregational Meeting?

A Congregational Meeting shall be presided over by the Minister (or Interim Minister) of the Congregation. If the Minister or Interim Minister is not present, the Constitution presents a priority list of persons who may chair the meeting as follows:

- a. Associate Minister
- b. Lay Pastor
- c. Deputy Chairperson of the Congregational Board
- d. Chairperson elected from among the members at

the meeting.

### What's the notice period for a Congregational Meeting?

The Notice Period is two clear Sundays before the meeting. Notice shall be given of a congregational meeting in the worship services. The date, time and place of the meeting shall be given by the Minister (or Interim Minister).

### Who can attend congregational meetings?

All members of the congregation in full communion may attend congregational meetings. (Remember the last Constitution Corner where we discussed who is a member in full communion and good standing).

### How are questions determined?

Questions shall be decided by simple majority. However, questions such as the calling of a Minister and the election of Elders are decided by two-thirds majority.

Job 1:1, 2:1-10 || Psalm 26 || Genesis 2:18-24 |  
Psalm 8 || Hebrews 1:1-4; 2:5-12 || Mark 10:2-16

Preparation involves the individual and begins with our devotional life and personal integrity. Here we seek to become more passionately committed to Jesus Christ. We specifically

ask God to deposit a passion and love for the unsaved. We ask God to give us a sensitivity to others, to discern the cries and the needs of those we encounter by divine appointment. We ask God to make us spiritually radiant and Christlike, overflowing with joy and clothed in the anointing. We ask God for a boldness to share the gospel and to remove doubts and fear. Preparation also involves the Church (God's called out people) and its lifestyle through practicing holiness, training, and discipleship. We also prepare for a response by practicing hospitality and by extending to the unsaved an invitation to follow Christ. Where hearts have not been regenerated, no recreation has taken place.

# COVID-19 PROTOCOLS

## AFFECTING CONGREGATIONAL LIFE IN JAMAICA AND THE CAYMAN ISLANDS

-From the Office of the General Secretary

There is now evidence of a community spread of COVID-19 in the Cayman Islands and as such the Government has reintroduced regulations to control the spread of the virus, including but not limited, to protocols for travel and gatherings. **Consequently, indoor gatherings are now restricted to 100 persons.** Please find attached suggested protocols for congregations in the Cayman Islands Regional Mission Council (CIRMC).

The Government of Jamaica, on September 22, 2021, announced amendments to an order under the Disaster Risk Management Act (DRMA) to facilitate in-person worship at churches on Saturdays and Sundays. These provisions are for the period **September 25 to October 28, 2021.**

Please note and be guided by the following:

1. **Church Services** – Sundays have been designated *No Movement Days*, however Church Services are allowed under the following conditions:

- **Persons are allowed movement to attend worship services between the hours of 7 a.m. and 3 p.m.**
- **The number of persons allowed in the sanctuary for worship on Sundays should be determined by the physical distancing requirement of a minimum of six feet between persons, but should not exceed 50 persons.**
- **Each person attending worship is required to have a completed Place of Worship Authorization Form (amended version attached).**

Please do the following prior to the service:

- i. Print and fill out all sections of the Authorization Form
- ii. Insert the name of the person who will participate in the service (use one Form for each person who will participate, do not exceed 20 persons)
- iii. Each Form should be signed by the Minister or Lay Pastor, including her/his own Form
- iv. Place your Church Stamp/Seal where indicated on each completed Form. This is a critical requirement (if you do not have a Church Stamp, visit your regional office and have them stamp each document)
- v. Ensure that each participant in the worship service has her/his copy of the Authorization Form, along with a valid form of identification, for presentation to the police at a check point

2. **Weddings** – the maximum number of persons allowed has moved **from 20 to 50 persons.**

The other relevant provisions remain the same as under:


3. **No crusades, conferences or conventions** will be permitted.
4. **Funeral services are allowed with at a maximum of 20 persons within the place of worship or facility.**
5. **Burials** are allowed for **30 minutes** Mondays to Fridays between **9 am and 4 pm** with a **maximum of 15 persons** at the graveside.
6. **Physical Gatherings** are limited to **10 persons.**
7. **Stay at home** – **persons 60 years** and over. Fully vaccinated persons are exempt.

Please note that the wearing of masks, hand sanitizing and social distancing are still required for public spaces and gatherings.


We invite you to comply with these provisions.

## Haiti Relief

Since the earthquake, which had its epicenter near Haiti, on Saturday August 14, 2021, has devastated the nation, the



country has been experiencing strong tremors. Many persons are still homeless and living under rubbles. Some are hesitant to erect concrete structures as they fear another earthquake happening at any given time.

At the last count, the death toll was 2,207, with 344 people still missing. The severe physical, economic and social impact on Haiti have been made more challenging as shortly thereafter they experienced the passage of Tropical Storm Grace. All of this follows the recent assassination of their President..

As part of our initial response as a church, we wish to offer financial support to the relief efforts in Haiti, through our established contacts there.

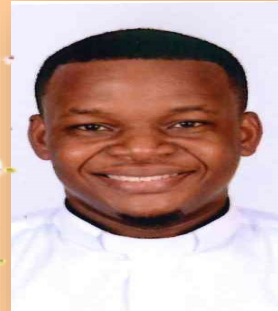
